1. Private Sessions

Standard fees for children attending on a fully private basis, or for hours attended above a funded entitlement.

| Session | Times | Hours | Daily Rate | Monthly (3 sessions) |

| Full Day | 08:30 – 17:30 | 9 hrs | £85.00 | £1,083.75 |
| Half Day AM | 08:30 – 13:30 | 5 hrs | £50.00 | £637.50 |
| Half Day PM | 12:30 – 17:30 | 5 hrs | £50.00 | £637.50 |

Monthly fee calculation: Weekly sessions × 51 weeks ÷ 12 months. Fees are charged monthly in advance.

Minimum attendance: 3 sessions per week for all children (full days, half days, or a combination).

Fee review: Fees are reviewed annually each April. One month's written notice will be given of any changes.

2. Government Funded Sessions

Funded children access their full entitlement completely free of charge. The sessions below show how each entitlement is delivered within our operating day.

Funded hours are always FREE — they appear on your invoice as a £0.00 line item, never as a discount.

You are not required to purchase any additional hours to access your funded entitlement. However, if you need more care beyond your funded session, you are very welcome to extend your child's day at our standard hourly rate — just let us know.

Optional extensions beyond funded sessions

If you wish your child to stay beyond their funded session, or arrive earlier, additional hours are available at our standard hourly rate. This is entirely optional and is never a condition of the funded place.

Trips: The only additional charge above your daily rate. Always optional, always communicated in advance, never a condition of your child's place.

4. Government Funded Entitlement Schemes

We are an approved Oxfordshire County Council funded provider. Funded hours are delivered on a term-time basis across 38 weeks of the year.

| 2-year-olds: Working Parent 30 hours | 2 yrs | Up to 1,140 hrs (30 hrs/wk) | Yes – 11-digit HMRC code | FREE |
| Under 2s: Working Parent (from Sept 2024) | 9–23 mths | Up to 1,140 hrs (30 hrs/wk) | Yes – 11-digit HMRC code | FREE |

30-hour & working parent code renewals

All working parent codes must be renewed every 3 months via HMRC before 31 March, 31 August and 31 December. If a code lapses, funded hours are paused until the following term.

5. Registration, Deposits & Discounts

| Fee Type | Amount | Details |
|-------------------------|--|--|
| Registration Fee | £85.00 (non-refundable) | Payable on acceptance of a place. Not charged to funded-only children with no additional paid sessions. |
| Holding Deposit | £50.00 per contracted day (refundable) | Secures your child's place. For funded children: refunded in full by the headcount date in the term the funded place is taken up. For private children: deducted from the final invoice on departure, provided required notice has been given and all fees are paid. |
| Sibling Discount | 10% off eldest sibling's fees | Applied automatically while more than one sibling is enrolled. Applies to standard session fees only – not registration fees, deposits, trips or optional charges. |
| Late Payment Fee | £25.00 | May be applied if payment is not received within 7 days of the invoice date. |

6. Planned Closures & Deductions

Fees are NOT charged for the following planned closures. Deductions are applied automatically to the relevant monthly invoice.

No deductions are given for sickness, personal absence or closures beyond our control. Fees cover a reserved place, not attendance.

7. Trips & Optional Activities

Trips and optional activities are the only charge parents may ever be asked to pay above the standard daily rate.

Every trip is always optional and will never be a condition of your child's place. Full details and costs will be communicated well in advance. No payment will ever be taken without prior written notice.
